







Wind Energy: Working with Farmers to create a new green-energy economy

The Canadian Wind Energy Association (CanWEA) is extremely disappointed that the Ontario Federation of Agriculture (OFA) last week called for a suspension of wind energy development at a time when thousands of farmers across the province are actively participating in, and seeking to participate in, wind energy developments. In fact, many of the issues that the OFA has identified as areas of concern are already being reviewed and examined through the Ontario Government's Feed-in-Tariff (FIT) Review process.

2011 was a record year for wind energy development in Ontario with the installation of 522 MW across the province. Farmers have always looked for new ways to use their land and resources productively, and wind energy provides a new economic opportunity to landowners in the form of stable revenue from land lease agreements. According to a report from ClearSky Advisors, The Economic Impacts of the Wind Energy Sector in Ontario 2011-2018, a typical lease agreement can provide a farmer with up to \$20,000 per year per turbine. If Ontario fully implements the government's Long-Term Energy Plan, it is expected that over \$313 million will be paid to

landowners in lease payments from the wind energy sector in Ontario from 2011 to 2018 alone//please click here to read more

NextEra Energy Resources takes concerns about human health very seriously. Although much has been written about health effects associated with wind turbines, we have found no credible, scientifically peer-reviewed study that demonstrates a link between wind turbines and negative health effects. On the contrary, the study "Wind Turbine Sound and Health Effects: An Expert Panel Review" (December 2009) had the following key conclusions:

- There is no evidence that the audible or sub-audible sounds emitted by wind turbines have any direct adverse physiological effects.
- The sounds emitted by wind turbines are not unique. There is no reason to believe, based on the sound levels and frequencies of the sounds and the panel's experience with sound exposures in occupational settings, that the sounds from wind turbines could plausibly have direct adverse health consequences.

In their recent decision on the Kent Breeze Wind project in Chatham-Kent, the Ontario Ministry of Environment states:

'The Chief Medical Officer of Health agreed to undertake a review of existing information and to consult with the Ontario Agency for Health Protection and Promotion and local medical officers of health on health effects related to wind turbines. The results of the review and consultation were published on May 20, 2010 and released in a report titled "The Potential Health Impacts of Wind Turbines". The review concluded that scientific evidence available to date does not demonstrate a direct causal link between wind turbine noise and adverse health effects. The sound level from wind turbines at common residential setbacks is not sufficient to cause hearing impairment or other direct health effects, and there is no scientific evidence to date that vibration from low frequency wind turbine noise causes adverse health effects.

Regarding shadow flicker, a common concern is its possible relationship to epilepsy. The Chatham-Kent Board of Health reviewed potential impacts in their report dated June 2008 and stated that 'The frequency of wind turbines is well below the current known documented threshold for triggering epilepsy symptoms".

Additionally, the Province of Ontario has appointed Dr. Siva Sivoththaman at the University of Waterloo as the Ontario Research Chair in Renewable Energy Technologies and Health. This position is dedicated to "actively monitoring and providing the latest in scientific research and data about any possible health impacts of renewable energy."

The Jericho Wind Energy Centre project will be designed to meet or exceed all the regulations prescribed by the Ministry of Environment and NextEra Energy Canada will have a communication and response program in place to address any concerns related to the operation of the project, should they arise.

NextEra Energy Resources operates 90 wind farms amidst a variety of agricultural uses and livestock operations. It has not been the experience of NextEra Energy Resources that wind turbine operations have any negative impact on livestock or crops. Quite the opposite in fact, many landowners find that

the guaranteed income from hosting a wind turbine helps to stabilize the economics of their operations over the long term as revenue to the landowner does not fluctuate according to the weather or commodity prices.

NextEra Energy Canada will use Industry Best Practices in the design of the project to minimize the risk of stray voltage to consumers and ensure our projects are built and maintained within acceptable levels as prescribed by the Ontario Energy Board's Distribution System Code and the Electrical Safety Authority.

Most cases of stray voltage occur when there is either:

- Improper grounding of on-site equipment (in which case it is an issue with on-site wiring)
- A change in current patterns on the distribution line, from generation or load, that exposes a pre-existing condition (in which case it is an issue with the distribution utility, not with the generator or load)

The turbines are therefore not the root of the problem, but like any change to the system, may expose faults in that system. All types of generation (wind generation using wind turbines included) must fully comply with utility requirements to ensure that the electricity they supply is compliant with grid standards.

Stray voltage problems require on-site inspection for grounding problems, or examination of power quality issues in collaboration with the distribution utility, Hydro One.

The required setbacks for a Class 4 Wind Facility in Ontario are outlined in Ontario Regulation 359/09 to the <u>Environmental Protection Act</u>. To summarize, the setbacks you had requested are as follows for our Jericho project which will be using GE 1.6MW turbines:

- woodlots requires a detailed Environmental Impact Study (EIS) if located within 120 metres of a significant woodlot;
- watercourses 30 metre minimum for wind turbines, and EIS where located within 120 metres of a watercourse;
- neighbouring property lines standard is hub height (80m); or alternatively it can be blade length + 10m (60m) with justification that it won't have impacts on neighbouring properties; or alternatively it can be as low as 0m where there is a signed agreement with the neighbour;
- homes falls under the classification of "receptors" which generally includes any building used for overnight accommodations; setback is 550 metres or the distance determined as a result of a detailed noise study, whichever is greater
- livestock buildings these buildings are not regulated by O.Reg 359/09 and there is no standard setback

The only difference above between participating and non-participating landowners, would be with respect to homes/receptors. There is no requirement for a 550 metre setback from homes/receptors on the same site as a turbine.
