1. Introduction

Summerhaven Wind, LP (Summerhaven) a wholly owned subsidiary of NextEra Energy Canada, ULC (NextEra), is constructing a wind energy project in the vicinity of the community of Nanticoke, in Haldimand County, Ontario. The Project received a Renewable Energy Approval (REA) from the Ministry of the Environment on March 16, 2012 and a subsequent amendment approval on January 2, 2013. The following sections of this Addendum Report describe the proposed modifications to the Project and resulting changes to the originally approved Water Assessment and Water Body Report.

1.1 The Proponent

The Project will be owned and operated by Summerhaven Wind, LP, a subsidiary of NextEra. NextEra's indirect parent company is NextEra Energy Resources, LLC. The proponent has not changed from the initial REA submission.

1.2 Project Study Area

The proposed Project is located in the vicinity of the community of Nanticoke, in Haldimand County, Ontario. The Project Study Area has not changed from the original REA submission.

2. Proposed Project Modifications

The proposed modifications to the Project include constructing a new access road on Lot 2, Concession 11, from Concession Road 3 south to Turbine 42 and widening a portion of the disturbance area for the access road between Turbine 40 and Turbine 41. No other changes will be made to the Project location or infrastructure.

The proposed Project modifications are summarized in **Table 2-1** which documents the following about each proposed modification:

- 1. A description of the modification and a rationale for the proposed modification; and
- 2. New potential environmental effects and corresponding mitigation measures.

Figure 2-1 illustrates the proposed modifications.

3. Edits to the Water Assessment and Water Body Report

Table 3-1 documents the edits to the Water Assessment and Water Body Report resulting from the modifications described above. The edits identified in this table specifically pertain to the investigations that were completed to identify all of the water bodies situated within 120 m of the Project Location. Four water features are located within the 120 m area of investigation of the new access road (Feature IDs 190, 191, 193 and 356). Three of these features were identified in the Natural Heritage Assessment for the original REA Approval. Additional site investigations found the presence of another water feature, Location ID 356 within the 120 m area of investigation. These four water features are not considered to be water bodies under the REA definition (O. Reg. 359/09), and therefore no mitigation measures are proposed.

The location of the four water features can be found in Figure 2-1.
